3 **Resolution supporting Fiscal Year 2009-2010 Community Development Block Grant**
4 **(CDBG) Action Plan Goals.**

6 WHEREAS, Under Title I of the Housing and Community Development Act of 1974, as
7 amended, and related federal regulations, the City and County of San Francisco is eligible to
8 apply for and receive Community Development Block Grant (CDBG) funding from the U.S.
9 Department of Housing and Urban Development (HUD); and

10 WHEREAS, The City and County of San Francisco anticipates receiving approximately
11 \$21,500,000 in CDBG Program Funds from HUD in 2009-10; and,

12 WHEREAS, on behalf of the City and County of San Francisco, the Mayor's Office of
13 Community Investment (MOCI) is preparing to release a Request for Proposals (RFP) for the
14 2009-10 CDBG Program; and,

15 WHEREAS, the RFP is in concert with the MOCI Consolidated Plan for program years
16 2005-2009; and,


17 WHEREAS, the Consolidated Plan was approved by HUD in 2005, and will be updated
18 to plan for 2010-2014; and,

19 WHEREAS, the Consolidated Plan details the Mayor's Office of Community Investment
20 and the Mayor's Office of Housing seven goals for the CDBG Program: 1) Promote economic
21 self-sufficiency for low and moderate income families; 2) Strengthen neighborhood vitality; 3)
22 Increase the provision of timely, relevant and effective social services; 4) Promote equity-
23 based public policy strategies; 5) Create housing opportunities for the homeless; 6) Create
24 affordable rental housing for individuals and families with incomes up to 60% of San Francisco
25 median income; and 7) Create homeownership opportunities for individuals and families up to

1 100% of San Francisco median income, and support existing homeownership programs
2 including funding housing counseling agencies to advise eligible San Franciscans of existing
3 homeownership programs, for families up to 120% of median income; now, therefore, be it
4 RESOLVED, That the Board of Supervisors continues to support the seven CDBG
5 Consolidated Plan goals, and the related 2009-2010 Request for Proposals to achieve these
6 goals.
