3 **Resolution authorizing the San Francisco Public Utilities Commission to accept and**
4 **expend a EPA FOG to Biodiesel Grant in the amount of \$175,000 through the West**
5 **Coast Collaborative.**

7 WHEREAS, San Francisco Public Utilities Commission (SFPUC) staff submitted a
8 \$175,000 grant application to the West Coast Collaborative, administered by the
9 Environmental Protection Agency, to conduct a thorough analysis of the Brown Grease to
10 Biodiesel Program; and

11 WHEREAS, The EPA notified the SFPUC in April, 2008, that the Brown Grease to
12 Biodiesel Program was awarded \$175,000 in West Coast Collaborative grant funds; and

13 WHEREAS, No matched funding is required from the FY 08-09 Wastewater Enterprise
14 Operating Budget; and

15 WHEREAS, In compliance with the California Environmental Quality Act the project is
16 Categorically Exempt from the need to prepare either an environmental assessment or
17 environmental impact statement; and

18 WHEREAS, This grant does not include an Annual Salary Ordinance (ASO)
19 Amendment; and

20 WHEREAS, The San Francisco Public Utilities Commission on July 22, 2008, adopted
21 resolution no. 08-0130 authorizing the General Manager to request permission from the Board
22 of Supervisors to accept and expend EPA West Coast Collaborative FOG to Biodiesel Grant
23 Funds; now, therefore, be it


24 **RESOLVED**, That the General Manager of the San Francisco Public Utilities
25 Commission, or designee, is authorized to accept and expend \$175,000 in EPA FOG to


1 Biodiesel Grant Funds through the West Coast Collaborative, for the aforementioned project
