3 **Resolution authorizing the Airport Commission to accept and expend three (3) grants**  
4 **totaling \$1,399,709.57 from the Bay Area Air Quality Management District (Air District)**  
5 **for acquisition of clean air vehicles and emissions control equipment by Airport**  
6 **transportation operators.**

8 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks to reduce vehicle  
9 emissions in the region and on terminal roadways; and

10 WHEREAS, The Air District assists public agencies in implementing emissions  
11 reduction projects, such as the addition of clean air vehicles to fleets; and,

12 WHEREAS, The Airport Commission in Resolutions 06-0203 and 07-0101 approved  
13 seeking, accepting, and expending Air District funds for clean air vehicles and equipment; and

14 WHEREAS, The Airport would administer the subject grants, disburse incentive funds  
15 to airport transportation operators, and provide the Air District with information concerning the  
16 new vehicles and equipment; and

17 WHEREAS, No Airport or City funds would be used for this program; and

18 WHEREAS, the grant does not require an ASO amendment; and


19 WHEREAS, Such projects continue the Airport's world leadership role in promoting  
20 clean fuel use among transportation providers; and

21 WHEREAS, The Airport proposes to maximize use of available grant funds on program  
22 expenditures by not including indirect costs in the grant budget; now, therefore, be it

23 RESOLVED, That, pursuant to San Francisco Administrative Code §10.171, the Board  
24 of Supervisors does hereby authorize the Airport Commission to accept and expend funds  
25 awarded in this grant; and be it

1 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
2 indirect costs in the grant budget.


