3 **Resolution authorizing the Mayor, on behalf of the City and County of San Francisco, to**
4 **accept and expend a gift from Macy’s West, Inc. in the amount of \$50,000 for operations**
5 **and programming at the Youth Center in the Excelsior District.**

7 WHEREAS, The City and County of San Francisco has financially supported the
8 construction and operation of a Youth Center in the Excelsior District through Community
9 Development Block Grant (CDBG) funding; and,

10 WHEREAS, The Excelsior Youth Center is a valuable physical asset to the community,
11 containing regulation basketball and volleyball courts, a multipurpose room, kitchen for
12 cooking classes, an audio/visual recording studio and a weight training facility; and,

13 WHEREAS, The Excelsior Youth Center provides structured services and activities to
14 neighborhood youth, including recreational activities, tutorial classes, arts and crafts, computer
15 lab, exercise classes, and neighborhood club meetings; and,

16 WHEREAS, Administrative Code Section 10.100-104 establishes the Mayor’s Excelsior
17 Youth Center Fund (Fund) as a category eight special fund for the purpose of receiving all
18 cash gifts, donations and contributions of money that may be offered for the Excelsior Youth
19 Center; and,

20 WHEREAS, Administrative Code Section 10.100-104 stipulates that monies in the Fund
21 shall be used exclusively for the development, furnishing, operation and maintenance of the
22 Excelsior Youth Center; and,

23 WHEREAS, Macy’s West, Inc. has made a gift to the Fund in the amount of \$50,000 for
24 operations and programming at the Excelsior Youth Center; now, therefore, be it



FURTHER RESOLVED, That the Mayor's Office of Community Investment shall expend and administer these funds for the benefit of the Excelsior Youth Center.


