3 **Resolution authorizing the Planning Department to retroactively accept and expend up**  
4 **to \$30,000 from the Association of Bay Area Government for Jefferson Street**  
5 **Redesign/Bay Trail Feasibility Study for FY2008-2009.**

7 WHEREAS, the City desires to improve the Jefferson Street Bay Trail to join with the  
8 Bay Trail network; and,

9 WHEREAS, an extensive analysis of how a multi-use path can be integrated into a  
10 street that has a streetcar line along much of its length and must be performed for integration;  
11 and,

12 WHEREAS, the Association of Bay Area Government (ABAG) has been delegated the  
13 administration of the grant for the development of the Bay Trail Project by the State Coastal  
14 Conservancy; and

15 WHEREAS, the grant does not require an ASO amendment; and

16 WHEREAS, The ABAG does not allow use of grant funds on indirect costs; now,  
17 therefore be it

18 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Planning  
19 Department to accept and expend a Jefferson Street Redesign grant up to \$30,000 from the  
20 Bay Trail Steering Committee; and

21 FURTHER RESOLVED, that the Board of Supervisors hereby waive inclusion of  
22 indirect costs in the grant budget; and

23 FURTHER RESOLVED, that the Director of the Planning Department is hereby  
24 authorized and empowered to execute, deliver and perform, in the name of the City and  
25 County of San Francisco, all applications, contracts, agreements, amendments and payment


