3 **Resolution appointing Todd Rydstrom, term ending June 5, 2009, to the Treasury**  
4 **Oversight Committee, residency requirement waived.**

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
7 does hereby confirm the appointment by the Treasurer of the following designated persons to  
8 serve as members of Treasury Oversight Committee, pursuant to the provisions of the San  
9 Francisco Administrative Code, Sections 10.79-4 through 10.79-6, for the term specified:

10 Todd Rydstrom, (residency requirement waived) succeeding Scott MacDonald,  
11 resigned, seat 4, must represent the public at large, for the unexpired portion of a four year  
12 term expiring June 5, 2009.

13 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 14 1. The membership of the Treasury Oversight Committee has a goal to be  
15 representative of the diversity of the City and County of San Francisco.
- 16 2. Applicant Todd Rydstrom, a new appointee, who is not a resident of San Francisco,  
17 is a person with experience that uniquely qualifies him/her to serve on the Treasury  
18 Oversight Committee.
- 19 3. The Treasury Oversight Committee has attempted to fill the position, for which Todd  
20 Rydstrom was nominated, with an individual who is a City resident and who has the  
21 specific experience, skills, and qualifications, but has been unable to do so at this  
22 time. The Rules Committee has certified that Todd Rydstrom is qualified to serve  
23 on the Treasury Oversight Committee.
- 24 4. After exercising due diligence, the Board of Supervisors concludes that there is no  
25 other possible representative, who is a resident of San Francisco and who has the

1 specific experience, skills, or qualifications possessed by this applicant, and who is  
2 willing to serve on the Treasury Oversight Committee at this time; and, be it

3 FURTHER RESOLVED, That the Board of Supervisors waives the residency  
4 requirement for Todd Rydstrom, as allowed in cases where no qualified City resident, willing  
5 to serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)  
6 appointed to boards, commissions, and advisory bodies established by legislative act of the  
7 Board of Supervisors to be resident(s) of the City and County of San Francisco.
