

1 [Accept-Expend Federal Pass-Through Grant – Asian Women’s Shelter]

3 **Resolution authorizing the Department of the District Attorney of the City and County**  
4 **of San Francisco to accept and expend a grant in the amount of \$10,000 from the Asian**  
5 **Women’s Shelter, allocated through the Office on Violence Against Women, Office of**  
6 **Justice Programs (OVW), to assist Asian and Pacific Islander (API) victims of domestic**  
7 **violence for fiscal year 2008-2010.**

9 WHEREAS, The City and County of San Francisco and the District Attorney desires to  
10 continue its agreement with the Asian Women’s Shelter to assist Asian and Pacific Islander  
11 (API) victims of domestic violence through the use of funds from the Office on Violence  
12 Against Women (OVW); and,

13 WHEREAS, The grant does not require an ASO amendment; and

14 WHEREAS, Asian Women’s Shelter proposes to maximize use of available grant funds  
15 on program expenditures by not including indirect costs in the grant budget; now, therefore,  
16 be it

17 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of  
18 the City and County of San Francisco to enter into a contract with the Asian Women’s Shelter,  
19 and to accept and expend pass-through funds from OVW for the purposes of providing  
20 assistance to Asian Pacific Islander victims of domestic violence;

21 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
22 indirect costs in the grant budget; and be it

23 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of  
24 the City and County of San Francisco the necessary Grant Award Agreements for purposes of  
25

1 the Asian Women's Shelter contract, including any extensions, augmentations or  
2 amendments thereof; and be it


3 FURTHER RESOLVED, That the District Attorney is authorized and empowered to  
4 execute, deliver and perform, in the name of the City and County of San Francisco, all  
5 applications, contracts, agreements, amendments and payment requests necessary for the  
6 purpose of securing Asian Women's Shelter grant funds and to implement and carry out the  
7 purposes specified in the applicable grant application; and be it

8 FURTHER RESOLVED, That any liability arising out of the performance of the Grant  
9 Award Agreement, including civil court actions for damages, shall be the responsibility of the  
10 grant recipient and the authorizing agency; and that the grant recipient and the authorizing  
11 agency will hold OVW harmless from any claims that may arise from the use of grant funds;  
12 be it

13 FURTHER RESOLVED, That grant funds received hereunder shall not be used to  
14 supplant expenditures controlled by this body.
