3 **Resolution authorizing the Department of the District Attorney of the City and County**
4 **of San Francisco to retroactively accept and expend a grant in the amount of \$402,457**
5 **through the United States Department of Justice, for a program entitled “Southeast**
6 **Community Response Network” for fiscal year July 2006 through June 2010.**

8 WHEREAS, The City and County of San Francisco desires to establish a certain
9 project designated the Southeast Community Response Network to be funded in part from
10 funds made available through the US Department of Justice (hereafter “DOJ”), Office of
11 Juvenile Justice and Delinquency Prevention; and

12 WHEREAS, The grant does not require an ASO amendment; and

13 WHEREAS, The Department proposes to maximize use of available grant funds on
14 program expenditures by not including indirect costs in the grant budget; now, therefore, be it

15 RESOLVED, That the Board of Supervisors hereby authorizes the District Attorney of
16 the City and County of San Francisco to retroactively accept and expend funds from DOJ for
17 the purposes of Southeast Community Response Network purposes; and be it

18 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
19 indirect costs in the grant budget; and be it.

20 FURTHER RESOLVED, That the District Attorney is authorized to execute on behalf of
21 the City and County of San Francisco the necessary Grant Award Agreements for Southeast
22 Community Response Network purposes, including any extensions, augmentations or
23 amendments thereof; and be it


24 FURTHER RESOLVED, That the District Attorney is authorized and empowered to
25 execute, deliver and perform, in the name of the City and County of San Francisco, all

1 applications, contracts, agreements, amendments and payment requests necessary for the
2 purpose of securing Southeast Sector Community Response Network grant funds and to
3 implement and carry out the purposes specified in the applicable grant application; and be it


4 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
5 Award Agreement, including civil court actions for damages, shall be the responsibility of the
6 grant recipient and the authorizing agency; and that the grant recipient and the authorizing
7 agency will hold DOJ harmless from any claims that may arise from the use of grant funds;
8 and be it

9 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
10 supplant expenditures controlled by this body.
