3 **Resolution authorizing the San Francisco Public Utilities Commission to accept and**
4 **expend a State Coastal Commission Grant in the amount of \$185,000.**

5 WHEREAS, San Francisco Public Utilities Commission (SFPUC) staff submitted a
6 \$185,00 grant application to the State Coastal Conservancy (SCC) for the Skyline Trail
7 segment of the Bay Area Ridge Trail; and

8 WHEREAS, The SCC notified the SFPUC in July 2008 that the Skyline Trail project
9 was awarded \$185,000 in grant funds to perform the planning, design, and permitting
10 necessary for construction of the Southern Skyline Blvd Alignment of the SFPUC Ridge Trail
11 on the Peninsula Watershed in San Mateo County; and,

12 WHEREAS, The 4.7 mile trail will traverse ridge lands east of Highway 35 within the
13 upper Crystal Springs Watershed in San Mateo County, which is owned and maintained by
14 the City and County of San Francisco for water supply purposes; and,

15 WHEREAS, Funding for the required matching funding is available from the FY 08-09
16 Water Enterprise Operating Budget and Project No. CUW250; and

17 WHEREAS, This grant does not include an Annual Salary Ordinance (ASO)
18 Amendment; and


19 WHEREAS, The San Francisco Public Utilities Commission on September 09, 2008,
20 adopted resolution no. 08-0156 authorizing the General Manager to request permission from
21 the Board of Supervisors to accept and expend State Coastal Commission grant funds; now,
22 therefore, be it



23 RESOLVED, That the General Manager of the San Francisco Public Utilities
