

1 [Resolution supporting Earth Hour 2009.]

2 **Resolution declaring March 28, 2009 between 8:30-9:30PM as Earth Hour in San**  
3 **Francisco and urging all city government buildings, public schools and public**  
4 **landmarks to turn off non-essential lighting on this date and time.**

7 WHEREAS, Earth Hour is a global event that involves over 400 cities in 35 countries  
8 on March 28, 2009 to increase awareness about the collective action that cities across the  
9 planet can take to conserve energy and fight climate change; and

10 WHEREAS, Earth Hour is a grassroots partnership between city governments, the  
11 World Wildlife Fund, and thousands of environmental and civil society groups; and

12 WHEREAS, Earth Hour will involve cities turning off all non-essential lighting between  
13 8:30-9:30PM on March 28, and will use the event to engage citizens to take specific actions to  
14 decrease their energy usage in their own day-to-day lives;

15  
16 WHEREAS, San Francisco led American participation in Earth Hour 2008 as the West  
17 Coast 'flagship' city and successfully turned off lights across the city, engaged over 100  
18 community groups in the campaign, and engaged thousands of San Franciscans to make  
19 changes in their own lives; and

20 WHEREAS, Earth Hour San Francisco 2009 will build off past success as an inclusive,  
21 grassroots event to broaden engagement of individuals, businesses, schools and building  
22 owners to take specific actions to reduce their carbon footprint and conserve energy; and

1 WHEREAS, These specific actions will be embodied in the "Earth Hour 24 x 7 Energy  
2 Challenge" that Earth Hour participants will take and includes: commercial building owners  
3 creating an energy benchmark for their building and then seeking to reduce energy over the  
4 next twelve months; small businesses participating in the City's Energy Watch program to  
5 receive energy audits of their business operations; and residents taking several clear, specific  
6 actions to reduce their consumption of electricity; now, therefore, be it

7  
8 RESOLVED, That the City and County of San Francisco endorses the mission of Earth  
9 Hour San Francisco 2009 to raise awareness about the connection between energy usage  
10 and global climate change and to cause local citizens to take specific actions to manage their  
11 energy usage; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors encourages city employees to  
13 turn off all non-essential lighting in city government buildings, public schools and public  
14 landmarks; and, be it

15 FURTHER RESOLVED, That the San Francisco Board of Supervisors declares March  
16 28, 2009 between 8:30-9:30PM to be Earth Hour in the City and County of San Francisco.
