2 TERMINAL.]

3 **Resolution approving and authorizing the execution of Lease No. GS-09B-01967 with**  
4 **the United States of America for terminal space to be occupied by the U.S. Federal**  
5 **Bureau of Investigation, a Federal agency, in the International Terminal of San**  
6 **Francisco International Airport.**

8 WHEREAS, The U.S. Federal Bureau of Investigation ("FBI") , the principal  
9 investigative arm of the United States Department of Justice, protects and defends the United  
10 States against terrorist and foreign intelligence threats, enforces the criminal laws of the  
11 United States, and provides criminal justice services to federal, state, international and  
12 municipal agencies, including San Francisco International Airport; and

13 WHEREAS, The FBI has requested approximately two thousand three hundred ninety-  
14 six (2,396) square feet of terminal space to accommodate its operational and administrative  
15 function in the International Terminal; and

16 WHEREAS, Airport staff has negotiated a lease with the General Services  
17 Administration with a Term of five (5) years for terminal space in the International Terminal to  
18 accommodate the FBI's operational and administrative offices (the "Lease"); and

19 WHEREAS, On August 4, 2009, pursuant to Resolution No. 09-0194, the Airport  
20 Commission approved the Lease with the United States of America. A copy of the form of the  
21 Lease is on file with the Clerk of the Board of Supervisors in File No. 091067 , which is  
22 hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

23 RESOLVED, That this Board of Supervisors hereby approves the Five-Year Lease for  
24 terminal space in the International Terminal, between the United States of America, and the  
25 City and County of San Francisco, acting by and through its Airport Commission.
