

1 [Accept & Expend State grants for environmental and agricultural projects.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
4 **and expend retroactively three grants totaling \$18,699.38, from the California**
5 **Department of Food and Agriculture (CDFA); for the periods of July 1, 2009 through**
6 **June 30, 2010, and January 1, 2010 through December 31, 2010.**

8 WHEREAS, DPH's Environmental Health Section was awarded three grants from the
9 CDFA, including Sudden Oak Death project (\$1,442.38), Weed Management Area Program
10 (\$16,757), and Nursery Stock Inspection (\$500) for a total of \$18,699.38 for the periods July
11 1, 2009 through June 30, 2010 for the Sudden Oak Death and Nursery Stock Inspection
12 projects and January 2010 through December 31, 2010 for the Weed Management Area
13 Program; and

14 WHEREAS, As a condition of receiving the grant funds, the CDFA requires the City to
15 comply with the terms of three separate agreements (the "Agreements"), copies of which are
16 on file with the Clerk of the Board of Supervisors in File No. 091174, which is hereby declared
17 to be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The grant does not require an ASO amendment and partially reimburses
19 the Department for four existing positions: two Agricultural Inspectors (Job Class #3450) at
20 0.005 FTE, one Junior Administrative Analyst (Job Class #1820) at 0.001 FTE for the period
21 of July 1, 2009 through June 30, 2010 and one Manager I (Job Class #0922) at 0.01 FTE for
22 the period of January 1, 2010 through December 31, 2010; and,

23 WHEREAS, The budget for the Sudden Oak Death Enforcement Activities includes a
24 provision for indirect costs of \$282.98; and

1 WHEREAS, The budget does not include a provision for indirect costs for the Weed
2 Management Area Program and Nursery Stock Inspection because CDFA does not allow it;
3 now therefore, be it


4 RESOLVED, That DPH is hereby authorized to accept and expend retroactively three

7 funded under this agreement as "G" or grant-funded positions which would terminate when
8 the agreement expires; and, be it


9 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and

11 be it


12 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


