7 WHEREAS, Del Monte Foods was founded in San Francisco in 1916; and

8 WHEREAS, Del Monte offers a broad line of California processed foods to the entire  
9 nation and was the first to advertise it nationally and include nutritional facts on its labels; and

10 WHEREAS, Del Monte Corporation is currently headquartered at two locations in San  
11 Francisco; and,

12 WHEREAS, Del Monte has announced that it will consolidate its 400 employees from  
13 the current locations above to one centralized location at One Maritime Plaza, where it will  
14 lease 153,000 square feet; and

15 WHEREAS, Del Monte Chairman and Chief Executive Officer Rick Wolford said that  
16 "San Francisco is a top U.S. city which enables us to attract top talent and our new One  
17 Maritime offices will enhance team work, upgrade our executional efficiency and importantly,  
18 provide room to grow" and that, "we're also very pleased that our headquarters will remain in  
19 the city's financial district where we'll have continued convenient access to business  
20 resources, public transportation, recreation and other amenities. Del Monte has been in San  
21 Francisco for more than a hundred years and is looking forward to continuing to be an integral  
22 part of the San Francisco community for many years to come"; now, therefore, be it

23 RESOLVED, That the Board of Supervisors of the City and County of San Francisco,  
24 commends Del Monte Corporation for staying in San Francisco and contributing to the rebirth  
25 of the San Francisco economy.




