

1 [Accept and expend grant – Second Chance Act Prisoner Reentry Initiative.]

3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**  
4 **and expend retroactively a grant from the Bureau of Justice Assistance in the amount**  
5 **of \$600,000 to provide direct services for adult state prisoners and parolees; for the**  
6 **period of October 1, 2009 through September 30, 2010.**

7  
8 WHEREAS, DPH was awarded a grant from the Bureau of Justice Assistance in the  
9 amount of \$600,000 to fund the project entitled Second Chance Act Prisoner Reentry  
10 Initiative; for the period October 1, 2009 through September 30, 2010; and,

11 WHEREAS, The amount of matching funds required from in-kind donations and a cash  
12 match from the San Francisco Reentry Center totals \$858,887; and,

13 WHEREAS, DPH will subcontract with the Homeless Prenatal Program, the Iris Center,  
14 SF Clean City Coalition, SFDPH Housing and Urban Health, and Walden House, for a total  
15 amount of \$572,660 for the period of October 1, 2009 through September 30, 2010; and,

16 WHEREAS, The grant does not require an ASO amendment and reimburses DPH for  
17 three existing positions, including Manager I (job class #0922) at 0.10 FTE, Epidemiologist II  
18 (job class #2803) at 0.10 FTE, and Health Worker II (job class # 2586) at 0.25 FTE; and,

19 WHEREAS, The budget does not include a provision for indirect costs in order to  
20 maximize the use of grant funds on direct services; now therefore, be it

21 RESOLVED, That DPH is hereby authorized to accept and expend retroactively the  
22 grant from the Bureau of Justice Assistance in the amount of \$600,000; and, be it


23 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
24 indirect costs in the grant budget; and be it

1 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
2 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,  
3 be it


4 FURTHER RESOLVED, That the Controller is directed to designate the positions  
5 funded under this agreement as a "G" or grant-funded position which would terminate when  
6 the agreement expires.

7 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
8 agreement on behalf of the City.
