3 **Resolution determining that the issuance of a Type 21 off-sale general license to**  
4 **Patrick and Angela Buscovich, for The Wine Club located at 953 Harrison Street**  
5 **(District 6), will serve the public convenience or necessity of the people of the**  
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**  
7 **California Business and Professions Code, with conditions.**

9 WHEREAS, Patrick and Angela Buscovich are seeking issuance of a Type 21  
10 off-sale general license for The Wine Club, located at 953 Harrison Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly  
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 21  
18 off-sale general license to Patrick and Angela Buscovich for The Wine Club, located at  
19 953 Harrison Street will serve the public convenience or necessity of the people of the  
20 City and County of San Francisco.

21 Conditions: (1) The sales, service and consumption of alcoholic beverages shall  
22 only be permitted between the hours of 10:00 a.m. to 8:00 p.m. daily. (2) No noise shall  
23 be audible beyond the area under the control of the licensees. (3) The sale of distilled  
24 spirits in 200 ml (corresponds to half a pint) or similar sizes are strictly prohibited.

1 (4) No persons under the age of twenty-one (21 years of age) shall sell, furnish or  
2 deliver alcoholic beverages. (5) The exterior of the premises shall be equipped with  
3 lighting of sufficient power to illuminate and make easily discernible the appearance and  
4 conduct of all persons on or about the premises. Additionally, the position of such  
5 lighting shall not disturb the normal privacy and use of any neighboring residences.  
6 (6) The petitioners shall be responsible for maintain free of litter the area adjacent to the  
7 premises over which they have control. (7) Graffiti shall be removed from the premises  
8 and all parking lots under the control of the licensee with 72 hours of application. If the  
9 graffiti occurs on a Friday, weekend day, or on a holiday, the licensee shall remove the  
10 graffiti within 72 hours following the beginning of the next weekday.
