3 **Resolution authorizing the San Francisco Department of Public Health (DPH) to accept**
4 **and expend retroactively a grant in the amount of \$28,465 from the University of**
5 **California San Francisco (UCSF), to assist with a project entitled “Ghana MARPS Size**
6 **Estimation;” for the period of January 1, 2010, through March 31, 2010.**

8 WHEREAS, UCSF is the recipient of a grant award from the Centers for Disease
9 Control (CDC) to support the project entitled “Ghana MARPS Size Estimation;” and,

10 WHEREAS, Through this grant, UCSF has agreed to fund DPH in the amount of
11 \$28,465 for the period of January 1, 2010 through March 31, 2010; and,

12 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH
13 for two existing positions, Senior Physician Specialist (Job Class #2232) at 0.20 FTE and
14 Manager I (Job Class #0922) at 0.40 FTE, for the period of January 1, 2010 through March
15 31, 2010; and,

16 WHEREAS, A request for retroactive approval is being sought because DPH did not
17 receive notice of UCSF’s intent to fund the project until January 10, 2010; and,

18 WHEREAS, The budget includes a provision for indirect costs of \$3,050; now
19 therefore, be it

20 RESOLVED, That DPH is hereby authorized to accept and expend a grant in the
21 amount of \$28,465 from UCSF; and, be it

22 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
23 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
