3 **Resolution authorizing the San Francisco Recreation and Park Department to**
4 **retroactively accept and expend a gift in the amount of \$15,000 to cover the staff**
5 **overtime cost associated with the August 4th and 5th 2009 Maccabi Games volunteer**

8 WHEREAS, The Maccabi Games are a weeklong Olympic-style athletic competition for
9 Jewish teens from North America, Israel and other countries were participants learn about
10 their culture, help those who are less fortunate, and contribute to strengthening our greater
11 Jewish community; and

13 WHEREAS, The San Francisco Recreation and Park Department, on August 4th and
14 5th 2009, led 1,400 teens in restoring habitat, cleaning and replacing playground sand,
15 planting, removing ivy, painting picnic tables and bleachers, and pulling weeds at 17 park
16 locations; and

18 WHEREAS, The Maccabi Games Gift in the amount of \$15,000 will be allocated to the
19 San Francisco Recreation and Park Department to cover the cost of overtime associated with
20 the event; and

21 WHEREAS, The gift does not include indirect funds to maximize the use of the gift; and

22 WHEREAS, The execution of the gift does not require an ASO amendment; and

23 WHEREAS, The Recreation and Park Commission recommends that the San
24 Francisco Board of Supervisors accept and expend the Gift in the amount of \$15,000; now
25 therefore, be it



5 event; and be it




