7 WHEREAS, The San Francisco Foundation's environmental fund provides funding to  
8 non profits organizations and public agencies to promote sustainable practices and equitable  
9 development that guarantee livable communities and healthy environments; and,

10 WHEREAS, The Youth Stewardship Program has been engaging youth, 3<sup>rd</sup>-12<sup>th</sup> grade  
11 in habitat restoration and environmental education projects in parks city-wide for the past  
12 twelve years; and,

13 WHEREAS, The Youth Stewardship Program meets the objectives of the San  
14 Francisco Foundation environmental fund; and,

15 WHEREAS, The San Francisco Foundation's grant will be allocated to non-profit Urban  
16 Service Project for Contractual services; and,

17 WHEREAS, The grant does not include indirect funds to maximize the use of the grant;  
18 and,

19 WHEREAS, The grant does not require an ASO amendment; and

20 WHEREAS, The Recreation and Park Commission by Resolution number **0703-007** did  
21 recommend the San Francisco Board of Supervisors to apply, accept and expend a grant in  
22 the amount of up to \$30,000 from the San Francisco Foundation for the Recreation and Park  
23 Department's Volunteer Services Division; now, therefore, be it


RESOLUTION NO.

8 and submit all documents including, but not limited to, applications, agreements, and so on,  
9 which may be necessary for the completion of the aforementioned program.




