13 the Free Speech Movement; and

14 WHEREAS, Following her graduation, Jill Lerner entered the workforce as a teacher at  
15 Martin Luther King Middle School in Berkeley; and

16 WHEREAS, While raising two children, Casey and Neil, Jill went to work as a paralegal  
17 in several San Francisco law firms; and

18 WHEREAS, Jill joined the Golden Gate Democratic Club in the 1980's, eventually  
19 becoming president, where she became inspired and impassioned about government and  
20 public service on a local level; and

21 WHEREAS, In the Spring of 1993, Jill Lerner came to work at City Hall with Supervisor  
22 Terrence Hallinan as a legislative aide; and

23 WHEREAS, In 1995, Jill served as one of the first aides for newly-elected Supervisor  
24 Mabel Teng; and

1           WHEREAS, In the fall of 1995, Jill Lerner joined the Office of the Chief Administrative  
2 Officer of the City & County, which then became the Office of the City Administrator; and

3           WHEREAS, Jill Lerner is officially retiring from the City and County of San Francisco on  
4 Friday, June 18<sup>th</sup>; now, therefore, be it

5           RESOLVED, That the San Francisco Board of Supervisors commends Jill Lerner for  
6 her years of dedicated service to the people of our City, and wishes her the absolute best in  
7 all of her future endeavors.
