3 **Resolution authorizing the San Francisco Department of Public Health to accept and**  
4 **expend retroactively a grant in the amount of \$101,261 from the Public Health**  
5 **Foundation Enterprises, Inc., to assist with a project entitled "Prevention Umbrella for**  
6 **MSM in the Americas" for the period of April 1, 2010, through March 31, 2011.**

8 WHEREAS, The Public Health Foundation Enterprises, Inc. is the recipient of a grant  
9 award from the National Institutes of Health (NIH) to fund a project entitled "Prevention  
10 Umbrella for MSM in the Americas (PUMA);" and,

11 WHEREAS, Through this grant, the Public Health Foundation Enterprises, Inc. (PHFE)  
12 has agreed to fund DPH in the amount of \$101,261 for the period of April 1, 2010 through  
13 March 31, 2011; and,

14 WHEREAS, PHFE is allocating funds annually but intends to fund the project for three  
15 years, in which DPH will get a total amount of \$657,488 through March 31, 2013; and,

16 WHEREAS, As a condition of receiving the grant funds, PHFE requires the City to  
17 enter into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the  
18 Board of Supervisors in File No. 100673; which is hereby declared to be a part of  
19 this resolution as if set forth fully herein; and,

20 WHEREAS, An ASO amendment is not required as the grant partially reimburses DPH  
21 for two existing positions, one Senior Physician Specialist (Job Class #2232) at 0.10 FTE and  
22 one Chief Medical Director (Job Class #2237) at 0.25 FTE, for the period of April 1, 2010  
23 through March 31, 2011; and,

24 WHEREAS, A request for retroactive approval is being sought because the DPH did  
25 not receive the award until April 29, 2010 with a project start date of April 1, 2010; and,
