

1 [Authorizing the Sheriff's Department to amend its contract with ARAMARK Correctional
2 Services, LLC (formally known as ARAMARK Correctional Services, Inc.) for Jail Food
3 Services - Not to Exceed \$30,500,000]

4 **Resolution authorizing the Sheriff's Department to retroactively enter into a Third**
5 **Amendment to the Agreement between the City and County and ARAMARK**
6 **Correctional Services, LLC (ARAMARK), to increase the contract amount from**
7 **\$22,885,229 to an amount not to exceed \$30,500,000 and to extend the contract term to**
8 **June 30, 2012.**

10 WHEREAS, the Board of Supervisors approved the Controller's certification that
11 county jail food service management operations can practically be performed by a
12 private contractor at a lower cost than if work were performed by City employees at
13 budgeted levels, Proposition J approved yearly; and,

14 WHEREAS, the Board of Supervisors approved a contract for the preparation
15 and provision of meals in the San Francisco County Jails with ARAMARK Correctional
16 Services, LLC, contained in File No. 050216 dated March 23, 2005 in the Amount of
17 \$15,227,132 with a four-year term; and,

18 WHEREAS, The Sheriff's Department executed the First Amendment to the
19 Agreement March 16, 2007, to increase contract prices in accordance with the terms of
20 the agreement; and,

21 WHEREAS, The Sheriff's Department executed the Second Amendment to
22 increase the total contract amount to \$22,885,229 and to extend the term of the
23 Agreement to June 30, 2010, which amendment is on file with the Clerk of the Board of
24 Supervisors in File No. 08110, Resolution No. 432-08, dated October 30, 2008; and,

1 WHEREAS, Charter Section 9.118, "Contract and Lease Limitations", subsection
2 (b), requires Board of Supervisors' approval of an amendment of greater than \$500,000
3 to a contract of greater than \$10 million; and,

4 WHEREAS, ARAMARK Correctional Services, LLC has agreed to provide new
5 equipment and upgrade mechanical components of all existing jail refrigerators, at no
6 charge to the Sheriff's Department, for an estimated equipment value of \$150,000; and,

7 WHEREAS, The Sheriff's Department has negotiated savings with ARAMARK by
8 menu revisions and a kitchen closure, and negotiated to omit staff meals from the
9 ARAMARK contract; and

10 WHEREAS, Effective July 1, 2010, the City and ARAMARK negotiated a change
11 from a fixed price to a price per meal contract, determined in accordance with a sliding
12 scale, based on the average weekly meal count; and

13 WHEREAS, The Sheriff's Department has prepared this proposed Third
14 Amendment to increase the total contract amount to \$30.5 million and to extend the
15 term of the Agreement to June 30, 2012, which amendment is on file with the Clerk of
16 the Board of Supervisors in File No. 100919, which is hereby declared to be a part of
17 this resolution as if set forth fully herein; now, therefore, be it

18 RESOLVED, That the Board of Supervisors authorizes the Sheriff's Department
19 to retroactively execute the Third Amendment to the Agreement with ARAMARK
20 Correctional Services, LLC in increasing the contract total to an amount not to exceed
21 \$30.5 million and extending the contract term through June 30, 2012.
