9 WHEREAS, The California Cultural and Historical Endowment has received an
10 appropriation from Propositions 40 California Clean Water, Clean Air, Safe Neighborhood
11 Parks, and Coastal Protection Act of 2002 which provides funds to the State of California for
12 grants to eligible Applicants; and,

13 WHEREAS, The California Cultural and Historical Endowment may distribute funds
14 from Proposition 40 to Projects that provide a thread of California's cultural and historical
15 resources; and,

16 WHEREAS, The Palace of Fine Arts Historical Landscape and Park Improvements
17 Project meets the objectives of the CCHE program; and,

18 WHEREAS, The California Cultural and Historical Endowment approved funding for the
19 Palace of Fine Arts Historical Landscape and Park Improvement Project in the amount of
20 \$500,000; and,


21 WHEREAS, The Applicant will enter into an agreement with the State of California for

23 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
24 therefore, be it

1 RESOLVED, That the City and County of San Francisco hereby approves the
2 acceptance and expenditure of a grant in the amount of \$500,000 for Palace of Fine Arts
3 Historical Landscape and Park Improvement Project from the California Cultural and Historical
4 Endowment Program; and, be it


5 FURTHER RESOLVED, That the City and County of San Francisco waives inclusion of
