

1 [Liquor License Transfer, 1530 Haight Street]

3 **Resolution determining that the premise to premise transfer of a Type 20 off-sale**
4 **beer and wine liquor license from 2 Harrison Street to 1530 Haight Street (District**
5 **5), to Bobby Vardakastanis for Haight Street Market, Inc., dba Haight Street**
6 **Market, will serve the public convenience or necessity of the people of the City**
7 **and County of San Francisco, in accordance with Section 23958.4 of the**
8 **California Business and Professions Code, with conditions.**

10 WHEREAS, Bobby Vardakastanis is seeking the transfer of a Type 20 off-sale
11 beer and wine liquor license from 2 Harrison Street to 1530 Haight Street for Haight
12 Street Market, Inc., dba Haight Street Market; and,

13 WHEREAS, The Planning Department has verified that the area is properly
14 zoned and recommends approval; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 **RESOLVED, That in accordance with Section 23958.4 of the California Business**
18 **and Professions Code, the Board of Supervisors of the City and County of San**
19 **Francisco hereby determines for the foregoing reasons that the transfer of a Type 20**
20 **off-sale beer and wine liquor license to Bobby Vardakastanis for Haight Street Market,**
21 **Inc., dba Haight Street Market, will serve the public convenience or necessity of the**
22 **people of the City and County of San Francisco.**

23 Conditions: (1) Sales and service of alcoholic beverages shall be permitted
24 between the hours of 9:00 a.m. and 9:00 p.m. daily. (2) No more than 10% of the
25 square footage of the premises will be used for the display of alcoholic beverages. (3)

1 No noise shall be audible beyond the area under control of the license. (4) Loitering
2 (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is
3 prohibited on any sidewalks or property adjacent to the licensed premises under the
4 control of the licensee. (5) There shall be no cups, glasses, or similar receptacles
5 commonly used for the drinking of beverages, sold, furnished, or given away at the
6 petitioner's premises in quantities of less than twenty-four (24) in their original multi-
7 container package. (6) All ice shall be sold at or above prevailing prices in the area
8 and in quantities of not less than three (3) pounds per sale and shall not be given away
9 free. (7) No person under the age of 21 shall sell or deliver alcoholic beverages. (8)
10 No wine shall be sold with an alcoholic content of great than 15% by volume except for
11 "Dinner Wines" which have been aged two years or more and maintained in corded
12 bottles. (9) Wine shall not be sold in bottles or containers smaller than 750 ml. (10)
13 No malt beverage shall be sold with an alcoholic content great than 5.7% by volume.
14 (11) The sale of beer or malt beverages in quantities of 16 oz., 22 oz., 32 oz., 40 oz., or
15 similar size containers is prohibited. (12) No beer or malt beverages shall be sold in
16 quantities of less than manufacturer pre-packaged six (6) packs per sale with the
17 exception of wine-coolers, beer coolers which must be sold in manufacturer pre-
18 packaged multi-unit quantities of four (4) or more.




