19 organizations to replicate; and,


20 WHEREAS, This project is building, in both San Francisco and Nanyuki, the

2 inclusion of indirect costs in the grant budget, and, be it


3 FURTHER RESOLVED, That the Arts Commission's request, which involves no ASO


