

1 [Accept and Expend Grant - Arelious Walker Drive Stairway Improvement Project -
2 \$1,109,000]

3 **Resolution authorizing the Department of Public Works to accept and expend a federal**
4 **grant in the amount of \$1,109,000 from the Metropolitan Transportation Commission for**
5 **the Arelious Walker Drive Stairway Improvement Project.**

7 WHEREAS, As the Congestion Management Agency for San Francisco, the San
8 Francisco Transportation Authority (SFCTA) is responsible for establishing project priorities
9 for programming in the Regional Transportation Improvement Program (RTIP), subject to
10 concurrence by the Metropolitan Transportation Commission (MTC); and,

11 WHEREAS, MTC is responsible for programming projects eligible for Transportation
12 Enhancements funds, pursuant to California Government Code Section 14527(b), for
13 inclusion in the RTIP, and submission to the California Transportation Commission, for
14 inclusion in the STIP; and,

15 WHEREAS, In October, 2009 the San Francisco Redevelopment Agency (RDA)
16 submitted an application to the SFCTA for \$1,109,000 in Transportation Enhancements funds
17 from the 2010 RTIP for the Arelious Walker Dr. Stairway Improvement Project; and,

18 WHEREAS, In November 2009, the SFCTA Board approved Resolution 10-33
19 adopting San Francisco Project Priorities for the 2010 RTIP and approving the recommended
20 programming of \$3,378,500 in TE funds to six projects including \$1,109,000 for the Arelious
21 Walker Dr. Stairway Improvement Project and transmitting these priorities to the Metropolitan
22 Transportation Commission; and,

23 WHERAS, In January 2010, the MTC approved Resolution 3938 adopting the RTIP,
24 which included the recommended programming of the SFCTA; and

1 WHEREAS, The RDA was awarded the grant and has requested to transfer the grant
2 to the Department of Public Works (DPW), including project management, accounting,
3 programming and reporting; and

4 WHEREAS, The DPW is a sponsor of transportation projects eligible for Transportation
5 Enhancements funds; and,

6 WHEREAS, The DPW has agreed to assume responsibility for the grant; and,

7 WHEREAS, The grant does not require a local match; and,


8 WHEREAS, The grant does not require an ASO amendment; and,

9 WHEREAS, The grant budget includes provisions for indirect costs of approximately
10 \$8,600; now, therefore be it


11 RESOLVED, That the San Francisco Board of Supervisors authorizes the Director of
12 Public Works or his/her designee to accept and expend a \$1,109,000 federal grant from MTC
13 for the Arelious Walker Stairway Project; and be it

14 FURTHER RESOLVED, That Director of Public Works or his/her designee is
15 authorized to execute all documents pertaining to the project with Caltrans.
