

1 [Accept and Expend Grant - Out-of-School-Time Online Homework Help Program - \$20,000]

2 **Resolution authorizing the Department of Public Library to accept and expend a grant**
3 **in the amount of \$20,000 from the California State Library as part of the Federal Library**
4 **Services and Technology Act the Out-of-School-Time Online Homework Help Program.**

5 WHEREAS, The Public Library serves the City and County of San Francisco, a highly
6 urban and diverse area; and

7 WHEREAS, San Francisco is home to 139,630 elementary through college age young
8 people ages 6-24; and

9 WHEREAS, Twenty-seven percent of children live with a high school dropout, fifty-six
10 percent of families with children are Hispanic and Asian/Pacific Islanders, and twenty-four
11 percent of the City's children are in single parent households; and

12 WHEREAS, This combination of factors indicates a need for out-of-school-time
13 homework support for San Francisco students; and

14 WHEREAS, The Public Library has a goal of supporting student success; and

15 WHEREAS, The grant does not require an ASO amendment; and

16 WHEREAS, The California State Library requires that all indirect costs not be allowed
17 and must be provided in-kind by the recipient library; now, therefore, be it

18 RESOLVED, That the Public Library accept and expend a grant in the amount of
19 \$20,000 from the California State Library as part of the Federal Library Services and
20 Technology Act (LSTA) to provide out-of-school-time homework support for San Francisco
21 students; and be it

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
23 indirect costs in the grant budget.




