

1 [Contract – San Francisco AIDS Foundation - Housing and Urban Rent Subsidies Services]

3 **Resolution approving a contract between the San Francisco Department of Public**  
4 **Health and the San Francisco AIDS Foundation for rent subsidies services for people**  
5 **living with HIV/AIDS.**

7 WHEREAS, The Department of Public Health has responsibility for providing primary  
8 health and prevention care to residents of San Francisco living with HIV/AIDS; and

9 WHEREAS, The Department conducted a Request for Proposals for rent subsidies  
10 services for San Franciscans living with HIV/AIDS which resulted in the selection of the  
11 San Francisco AIDS Foundation for award of a contract;

12 WHEREAS, The Department requests approval of the contract for a term of five years  
13 for the period of July 1, 2011, through June 30, 2016, in the total amount of \$19,685,910, with  
14 five additional one-year options to renew the contract, as allowed for in the Request for  
15 Proposals; and

16 WHEREAS, Chapter 9.118 of the San Francisco Charter states that contracts requiring  
17 anticipated expenditures of over \$10 million must be approved by the Board of Supervisors;  
18 and

19 WHEREAS, The Department of Public Health estimates that the annual payment of this  
20 contract may be increased over the original contract amount, as additional funds become  
21 available between July 1, 2011 and the end of the contract term, with five additional one-year  
22 options to renew; and

23 WHEREAS, a copy of this contract is on file with the Clerk of the Board of Supervisors  
24 in File No. 110664, which is hereby declared to be a part of this resolution as if set forth fully  
25 herein; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Public  
2 Health and the Office of Contract Administration/Purchaser, on behalf of the City and County  
3 of San Francisco, to execute a contract with San Francisco AIDS Foundation for the provision  
4 of rental subsidy services to residents of San Francisco living with HIV/AIDS for the period of  
5 July 1, 2011 through June 30, 2016; and, be it


6 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director
