3 **Resolution authorizing Tax Collector Attorney to file suit against responsible relatives**  
4 **to recover value of services rendered at hospital facilities operated by the San**  
5 **Francisco Department of Public Health.**

7 WHEREAS, It appears from the San Francisco Treasurer and Tax Collector's letter  
8 dated July 13, 2011, identifying those recipients of medical aid at San Francisco medical  
9 facilities who have relatives legally liable for the cost of medical treatment rendered to their  
10 minor-child, which letter is on file with the Clerk of the Board of Supervisors in  
11 File No. 110390, which is hereby declared to be a part of this resolution as if set forth fully  
12 herein; and,

13 WHEREAS, It further appears that the Tax Collector has determined that both of the  
14 below-named parents are jointly and severally liable and each has the financial ability to pay  
15 for the aid rendered to their minor child by the San Francisco Department of Public Health,  
16 both at the time the aid was rendered and at the present time; now, therefore, be it

17 RESOLVED, That the Tax Collector Attorney be, and hereby is, authorized and  
18 directed to institute legal proceedings against the herein named relatives deemed responsible  
19 for the payment of said medical services, and to seek recovery in full of charges for medical  
20 aid rendered at San Francisco Department of Public Health medical facilities pursuant to  
21 Section 17300 of the California Welfare and Institutions Code.
