8 WHEREAS, The San Francisco Tennis Coalition is a tennis advocacy group in the city
9 of San Francisco that unifies public and private tennis organizations and individuals around
10 their mission to develop world-class public tennis facilities that are well-maintained, as well as
11 programs that host engaging and popular tennis programs for all ages and abilities; and

12 WHEREAS, The courts housed at the Golden Gate Park Tennis Complex have not
13 been resurfaced since 2001; and,

14 WHEREAS, San Francisco Tennis Coalition contributed equipment and materials to
15 resurface 12 courts at the Complex; and,


16 WHEREAS, The Recreation and Park Commission recommends that the San
17 Francisco Board of Supervisors retroactively accept and expend the gift in-place, valued at
18 \$45,680; and,

19 WHEREAS, The City recognizes the generosity of the San Francisco Tennis Coalition
20 with sincere appreciation; now, therefore, be it

21 RESOLVED, That the Board of Supervisors approves the Gift and authorizes the
22 Recreation and Park Department General Manager to retroactively accept and expend the
23 Gift in-place, valued at \$45,680, from the San Francisco Tennis Coalition for the resurfacing
24 of two banks of courts (courts 6-17) at the Golden Gate Park Tennis Complex.


