

1 [Accept and Expend Grant - Pest Exclusion- High Risk Inspections and Enforcement -
2 \$47,983.25]

3 **Resolution authorizing the Department of Public Health to retroactively accept and**
4 **expend a grant (Agreement No. 11-0127) in the amount of \$47,983.25 from the California**
5 **Department of Food and Agriculture, to participate in a program entitled Pest**
6 **Exclusion- High Risk Inspections and Enforcement for the period of July 1, 2011,**
7 **through June 30, 2012.**

9 WHEREAS, California Department of Food and Agriculture has agreed to fund San
10 Francisco Department of Public Health (DPH) in the amount of \$47,983.25 for the period of
11 July 1, 2011 through June 30, 2012; and,

12 WHEREAS, As a condition of receiving the grant funds, California Department of Food
13 and Agriculture requires the City to enter into an agreement (the "Agreement"), a copy of
14 which is on file with the Clerk of the Board of Supervisors in File No. 120155; which is hereby
15 declared to be a part of this resolution as if set forth fully herein; and,

16 WHEREAS, The purpose of this project will provide state funding to enhance pest
17 exclusion inspection activities performed at the local level by the County Agricultural
18 Commissioner offices; and,

19 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
20 partially reimburses DPH for four existing positions, one Agricultural Inspector (Job Class No.
21 3450) at .18 FTE, one Agricultural Inspector (Job Class No. 3450) at .18 FTE, one Manager I
22 (Job Class No. 0922) at .07 FTE, and one Jr. Administrative Analyst (Job Class No. 1820) at
23 .04 FTE, for the period of July 1, 2011, through June 30, 2012; and,

1 WHEREAS, A request for retroactive approval is being sought because DPH did not
2 receive notification of the agreement until December 20, 2011 for a project start date of July 1,
3 2011; and,

4 WHEREAS, The budget includes a provision for indirect costs in the amount of
5 \$9,668.82; now, therefore, be it

6 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively
7 in the amount of \$47,983.25 from California Department of Food and Agriculture; and, be it

8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
9 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
10 be it

11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 agreement on behalf of the City.


