3 **Resolution determining that the issuance of a Type 21 off-sale general license to**
4 **Farid Tawil for S.F. Gift and News, located at 350 California Street (District 3), will**
5 **serve the public convenience or necessity of the people of the City and County of**
6 **San Francisco, in accordance with Section 23958.4 of the California Business and**
7 **Professions Code, with conditions.**

9 WHEREAS, Farid Tawil is seeking the issuance of a Type 21 off-sale general
10 license for S.F. Gift and News, located at 350 California Street; and,

11 WHEREAS, The City Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 21
18 off-sale general license to Farid Tawil for S.F. Gift and News, located at 350 California
19 Street, will serve the public convenience or necessity of the people of the City and
20 County of San Francisco.

21 Conditions: (1) Sales of alcoholic beverages shall only be between the hours of
22 7:00 a.m. and 9:00 p.m., daily. (2) The sale of distilled spirits in sizes smaller than 375
23 ml is strictly prohibited. (3) No malt beverages shall be sold with an alcoholic content
24 greater than 5.7% by volume. (4) There shall be no plastic cups, disposable glasses,

1 or similar disposable receptacles commonly used for the drinking of beverages, sold,
2 furnished, or given away at the petitioner's premises in quantities of less than twenty-
3 four (24) in their original multi-container package. (5) All ice shall be sold at or above
4 prevailing prices in the area and in quantities of not less than three (3) pounds per sale
5 and shall not be given away free. (6) Wine shall not be sold in bottles or containers
6 smaller than 750 ml. (7) Wine-coolers, beer coolers, or pre-mixed distilled spirit
7 cocktails must be sold in manufacturer pre-packaged multi-unit quantities.


