

1 [Liquor License Transfer - 165 Jefferson Street]

3 **Resolution determining that the transfer of a Type 48 on-sale general public**
4 **premises license from 247 Powell Street to 165 Jefferson Street (District 3), to**
5 **Nick Bovis for GDL SFO Inc., will serve the public convenience or necessity of the**
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code, and recommending that the California**
8 **Department of Alcoholic Beverage Control impose conditions on the issuance of**
9 **the license.**

11 WHEREAS, Nick Bovis is seeking the transfer of a Type 48 on-sale general
12 public premises license from 247 Powell Street to 165 Jefferson Street for GDL SFO
13 Inc.; and,

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and,

16 WHEREAS, The Police Department has filed no protests with the Department of
17 Alcoholic Beverage Control under Section 24013 of the California Business and
18 Professions Code, and recommends that the Department of Alcoholic Beverage Control
19 issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are: 1)
21 Sales, service and consumption of alcoholic beverages shall be permitted from 8:00 am
22 to 2:00 am daily; 2) The sale of alcoholic beverages for off-sale consumption is strictly
23 prohibited; 3) No noise shall be audible beyond the area under the control of the
24 licensee(s) as defined on the ABC-257 dated 06/15/2012; and 4) Loitering (loitering is

1 defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on
2 any sidewalks or property adjacent to the licensed premises under the control of the
3 licensee(s) as depicted on the ABC-257 dated 06/15/2012; now, therefore, be it

4 RESOLVED, That in accordance with Section 23958.4 of the California Business
5 and Professions Code, the Board of Supervisors of the City and County of
6 San Francisco hereby determines for the foregoing reasons that the transfer of a Type
7 48 on-sale general public premises license from 247 Powell Street to 165 Jefferson
8 Street, to Nick Bovis for GDL SFO Inc., will serve the public convenience or necessity of
9 the City and County of San Francisco; and

10 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
11 San Francisco hereby endorses and adopts the recommendations of the Police
12 Department listed above, and recommends that the Department of Alcoholic Beverage
13 Control issue the license with those conditions.
