

1 [Accept and Expend Grant - Hepatitis B Early Identification and Linkage to Care for Foreign-
2 Born Persons with Hepatitis B - \$300,000]

3 **Resolution authorizing the San Francisco Department of Public Health to retroactively**
4 **accept and expend a grant in the amount of \$300,000 from Centers for Disease Control**
5 **and Prevention to participate in a program entitled "Hepatitis B Early Identification and**
6 **Linkage to Care for Foreign-Born Persons with Hepatitis B in San Francisco" for the**
7 **period of September 30, 2012, through September 29, 2013.**

9 WHEREAS, The Centers for Disease Control and Prevention (CDC) has agreed to
10 fund Department of Public Health (DPH) in the amount of \$300,000 for the period of
11 September 30, 2012, through September 29, 2013; and

12 WHEREAS, As a condition of receiving the grant funds, CDC requires the City to enter
13 into an agreement (Agreement), a copy of which is on file with the Clerk of the Board of
14 Supervisors in File No. 130024; which is hereby declared to be a part of this
15 Resolution as if set forth fully herein; and

16 WHEREAS, The purpose of this project is to test at least 4,000 foreign-born individuals
17 to ensure that they know their hepatitis B status and link to care anyone who tests positive for
18 hepatitis B infection; and

19 WHEREAS, DPH will subcontract with Public Health Foundation Enterprises, Inc;
20 Community Initiatives; and Asian Week Foundation, in the total amount of \$251,200; for the
21 period of September 30, 2012 through, September 29, 2013; and

22 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
23 partially reimburses DPH for two existing positions, one Manager I (Job Class No. 0922) at
24 .15 FTE and one Epidemiologist I (Job Class No. 2802) at .20 FTE for the period of
25 September 30, 2012 through, September 29, 2013; and

1 WHEREAS, A request for retroactive approval is being sought because DPH did not
2 receive notification of the award until November 23, 2012, for a project start date of
3 September 30, 2012; and

4 WHEREAS, The budget includes a provision for indirect costs in the amount of \$7,471;
5 now, therefore, be it

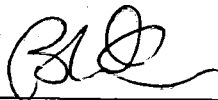
6 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
7 in the amount of \$300,000 from CDC; and

8 RESOLVED, That DPH is hereby authorized to enter retroactively into a subcontract
9 agreement in the amount of \$251,200 with Public Health Foundation Enterprises, Inc;
10 Community Initiatives; and Asian Week Foundation for services under the grant entitled
11 Hepatitis B Early Identification and Linkage to Care for Foreign-Born Persons with Hepatitis B
12 in San Francisco; for the period of September 30, 2012 through, September 29, 2013; and, be
13 it

14 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
15 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
16 be it

17 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
18 Agreement on behalf of the City.
