

1 [Correcting the Accept and Expend Grant Amount in Resolution No. 384-12 - Compensation
2 for Crime Victims - \$2,142,414]

3 **Resolution correcting the not to exceed amount in Resolution No. 384-12, a resolution**
4 **retroactively authorizing the Office of the District Attorney to accept a grant from the**
5 **California Victim Compensation and Government Claims Board for a project entitled**
6 **“Joint Powers Agreement”, from \$714,138 to \$2,142,414 for the period of July 1, 2012,**
7 **through June 30, 2015.**

9 WHEREAS, Resolution No. 384-12 authorized the District Attorney to retroactively
10 accept and expend up to \$714,138 from the California Victim Compensation and Government
11 Claims Board to continue the Joint Powers Agreement for the period of July 1, 2012, through
12 June 30, 2015; and

13 WHEREAS, After the passage of Resolution No 384-12, the California Victim
14 Compensation and Government Claims Board requested that resolution be amended to
15 retroactively accept and expend up to \$2,142,414 for the period of July 1, 2012, through June
16 30, 2015; and

17 WHEREAS, The City and County of San Francisco desires to enter into an agreement
18 with the California Victim Compensation and Government Claims Board in accordance with
19 Government Section 13835 for the purpose of assisting victims and witnesses with
20 compensation claims; and

21 WHEREAS, Funds received hereunder shall not be used to supplant local funds that
22 would, in the absence of California Victim Compensation and Government Claims Board
23 Programs, be made available to support the assistance of victims and witnesses of crime; and,

24 WHEREAS, All positions supported by these funds shall be coded “G” in the District
25 Attorney’s budget; and

1 WHEREAS, The District Attorney proposes to maximize use of available grant funds on
2 program expenditures by not including indirect costs in the grant budget; and

3 WHEREAS, The grant does not require an amendment to the Annual Salary Ordinance
4 (ASO); now, therefore, be it

5 RESOLVED, That the Board of Supervisors amends Resolution No. 384-12 to increase
6 the not to exceed amount from \$714,138 to \$2,142,414 for the period of July 1, 2012, through
7 June 30, 2015; and, be it

8 FURTHER RESOLVED, That the District Attorney of the City and County of San
9 Francisco, or his designee, is retroactively authorized on behalf of the City and County of San
10 Francisco to contract for, accept and expend funds from the California Victim Compensation
11 and Government Claims Board to continue the Joint Powers Agreement; including any
12 extensions, augmentations or amendments thereof; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
14 indirect costs in the grant budget.


