8 WHEREAS, The Board of Supervisors authorized the Planning Department to apply  
9 for, accept, and expend \$2,380,000 in funding assigned to the MTC through Resolution No.  
10 020-13 on January 29, 2013; and

11 WHEREAS, The sources of the funds for the County Priority Development  
12 Implementation Program includes but are not limited to federal funding administered by the  
13 Federal Highway Administration (FHWA) such as Surface Transportation Program (STP)  
14 funding, Congestion Mitigation and Air Quality Improvement Program (CMAQ) funding and/or  
15 Transportation Alternatives (TA) funding for local Priority Development Area Planning and  
16 Implementation efforts spanning FYs2012-2013 through FYs2015-2016; and

17 WHEREAS, The SFMTA is the direct recipient of the E-76 obligation package issued  
18 by the California Department of Transportation on behalf of the FHWA, which authorizes the  
19 expenditure of federal funds; and

20 WHEREAS, The Board of Supervisors must approve the resolution of local support  
21 from MTA as the recipient of the E-76; now, therefore, be it

22 RESOLVED, That the SFMTA will act as the fiscal agent for \$2,380,000 in funds  
23 received by the San Francisco Planning Department through MTC Resolution 4035 for the  
24 implementation of the County Priority Development Area Planning and Implementation  
25 program.


