20 newspaper, pursuant to Section 2.80 and 2.80-1 of the Administrative Code; and

21 WHEREAS, In each year, the Board of Supervisors shall designate the outreach
22 periodical for each outreach community, pursuant to Section 2.81-3 of the Administrative
23 Code; and,

24 WHEREAS, The Board of Supervisors may designate neighborhood outreach papers,
25 pursuant to Section 2.81-4 of the Administrative Code; now therefore, be it

1 RESOLVED, That the Board designates the following newspapers, which circulate
2 primarily in the indicated communities and are printed in San Francisco, to be the outreach
3 newspapers for the indicated communities for FY 13-14:

4 African American	Small Business Exchange and the San Francisco Bay View
5 Chinese	Small Business Exchange, Sing Tao Daily and
6	The World Journal
7 Hispanic	Small Business Exchange, El Mensajero and El Reportero
8 Lesbian, Gay, Bisexual	Bay Area Reporter; and, be it
