

1 [Contract Amendment - HealthRIGHT 360 - \$18,471,407]

3 **Resolution retroactively approving an amendment to the contract between the**  
4 **Department of Public Health and HealthRIGHT 360 to provide mental health and**  
5 **substance abuse care services in the San Francisco County Jail system to extend the**  
6 **term by two and one half years, from the period of July 1, 2010, through June 30, 2012,**  
7 **to the period of July 1, 2010, through December 31, 2015, for a total contract term of**  
8 **five and one half years, and to increase the total contract amount by \$8,472,407 from**  
9 **\$9,999,000 to \$18,471,407.**

11 WHEREAS, The Department of Public Health, in order to provide a comprehensive and  
12 integrated system of medical, psychiatric and substance abuse care services to  
13 inmates/patients in the San Francisco County Jails system, conducted a Request for  
14 Proposals in July, 31, 2009, to solicit those services; and

15 WHEREAS, The Department selected and contracted with HealthRIGHT 360 for these  
16 services subsequently amending the contract as needed; and

17 WHEREAS, The Department of Public Health now wishes to extend the term by two  
18 and one half years, from July 1, 2010, through June 30, 2012, to July 1, 2010, through  
19 December 31, 2015, for a total contract term of five and one half years, and to increase the  
20 total contract amount by \$8,472,407 from \$9,999,000 to \$18,471,407; and

21 WHEREAS, A copy of this amendment is on file with the Clerk of the Board of  
22 Supervisors in File No. 130511, which is hereby declared to be a part of this resolution as set  
23 forth fully herein, now, therefore, be it

24 **RESOLVED**, That the Board of Supervisors hereby authorizes the Director of Public  
25 Health and the Office of Contract Administration/Purchaser to amend the contract with

1 HealthRIGHT 360 to provide mental health and substance abuse care services in the  
2 San Francisco County Jail system to extend the term by two and one half years, from July 1,  
3 2010, through June 30, 2012, to July 1, 2010, through December 31, 2015, for a total contract  
4 term of five and one half years, and to increase the total contract amount by \$8,472,407, from  
5 \$9,999,000 to \$18,471,407; and, be it

6 FURTHER RESOLVED, That the Board of Supervisors hereby authorizes the Director  
7 of Health and the Director of the Office of Contract Administration/Purchaser to make  
8 amendments to this contract, as needed that do not materially increase the obligations or  
9 liabilities of the City, and, be it

10 FURTHER RESOLVED, That within thirty (30) days of the contracts being fully  
11 executed by all parties, the Director of Health and/or the Director of the Office of Contract  
12 Administration/Purchaser shall provide the final contracts to the Clerk of the Board for  
13 inclusion into the official file (File No. 130511).
