

1 [Accept and Expend Grant - FY2013 Housing Opportunities for Persons with AIDS  
2 Performance Renewal - \$1,461,622]

3 **Resolution authorizing the Mayor's Office of Housing and Community Development, on**  
4 **behalf of the City, to accept and expend the FY2013 Housing Opportunities for Persons**  
5 **with AIDS Performance Renewal Grant from the U.S. Department of Housing and Urban**  
6 **Development in the amount of \$1,461,622 for the period of December 1, 2013, through**  
7 **November 30, 2016.**

9 WHEREAS, The U.S. Department of Housing and Urban Development (HUD), under  
10 the Continuing Appropriations Act, 2013, Pub. L. 112-175, issued the Standards for Fiscal  
11 Year 2013 Expiring Housing Opportunities for Persons with AIDS (HOPWA) Permanent  
12 Supportive Housing Renewal Applications on December 20, 2012; and

13 WHEREAS, The Mayor's Office of Housing and Community Development (MOHCD)  
14 submitted an application on February 20, 2013, on behalf of the City and County of San  
15 Francisco, to request an allocation of \$1,471,200 in HOPWA Permanent Supportive Housing  
16 Renewal funding for the Second Start Project; and

17 WHEREAS, The City and County of San Francisco was awarded \$1,461,622 in  
18 HOPWA funding for the Second Start Project as evidenced by the FY2013 HOPWA  
19 Performance Grant Agreement dated July 12, 2013, with approved program and budget  
20 details for the term of the agreement which begins December 1, 2013, and ends on November  
21 30, 2016, a copy of which is located in Board File No. 130976; and

22 WHEREAS, The committed leveraging for the term of the three year agreement  
23 includes \$450,000 in HOPWA entitlement funding; and

24 WHEREAS, The proposed grant does not require an Annual Salary Ordinance  
25 amendment; and

1           WHEREAS, The funding agency (HUD) does not allow use of grant on indirect costs;  
2 and

3           WHEREAS, An Environmental Review Record has been prepared by MOHCD and  
4 approved by the Certifying Officer for the Second Start Project with the National  
5 Environmental Policy Act (NEPA) and other applicable statutes and authorities, in particular  
6 those cited in 24 CFR Part 58 §§5 and 6, a copy of which is located in Board File No. 130976;  
7 and

8           WHEREAS, The Certifying Officer shall follow the provisions of NEPA to confirm and  
9 ensure that all projects funded under the HOPWA Program are in compliance with applicable  
10 federal regulations and requirements; now, therefore, be it

11           RESOLVED, That the Director of the Mayor's Office of Housing and Community  
12 Development is hereby authorized, on behalf of the Mayor, to accept and expend the FY2013  
13 HOPWA Performance Renewal Grant from HUD in the amount of \$1,461,622 in accordance  
14 with the purposes and goals for the funding as set forth in the FY2013 HOPWA Performance  
15 Grant Agreement; and, be it

16           FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
17 indirect costs in the grant budget; and, be it


18           FURTHER RESOLVED, That the Director of the Mayor's Office of Housing and  
19 Community Development is hereby authorized to enter into and execute agreements  
20 between the City and County of San Francisco and the various agencies consistent with the  
21 FY2013 HOPWA Performance Grant Agreement; and, be it

22           FURTHER RESOLVED, That the Director of the Mayor's Office of Housing and  
23 Community Development is hereby authorized to submit documentation and certifications as  
24 may be requested or required by HUD.


