4 **Resolution approving award of Professional Services Agreement for Airport Contract**
5 **No. 9312 - Elevator Maintenance Service to provide for maintenance, repair, testing,**
6 **and on-call emergency services for approximately 170 elevators at San Francisco**
7 **International Airport, between ThyssenKrupp Elevator Corporation and the City and**
8 **County of San Francisco, acting by and through its Airport Commission, in an amount**
9 **not to exceed \$11,000,000 pursuant to Charter, Section 9.118(b), for the period of**
10 **January 1, 2014, through December 31, 2018.**

12 WHEREAS, On October 22, 2013, pursuant to Resolution 13-0217, the Airport
13 Commission awarded the Professional Services Agreement – Elevator Maintenance Service
14 to ThyssenKrupp Elevator Corporation, for a five (5) year term, at a not to exceed amount of
15 \$11,000,000 for maintenance, repair, testing, and on-call emergency services for
16 approximately 170 elevators at the San Francisco International Airport; and,

17 WHEREAS, San Francisco Charter Section 9.118(b) provides that the agreements
18 entered into by a department, board or commission requiring anticipated expenditures by the
19 City and County of ten million dollars, shall be subject to approval by the Board of Supervisors
20 by resolution; and,

21 WHEREAS, The original contract is on file with the Clerk of the Board of Supervisors in
22 File No. 131054, which is hereby declared to be a part of this resolution as if set forth fully
23 herein; now, therefore, be it

24 RESOLVED, That the Board of Supervisors hereby approves the Award of
25 Professional Services Agreement for Airport Contract 9312 – Elevator Maintenance Services

1 between ThyssenKrupp Elevator Corporation and the City and County of San Francisco,
2 acting by and through its Airport Commission, for a five (5) year term, at a not to exceed
3 amount of \$11,000,000, copies of which are contained in Board of Supervisors'
4 File No. 131054; and, be it

5 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed
6 by all parties, the Airport Commission shall provide the final contract to the Clerk of the Board
7 for inclusion into the official file.


