

1 [Contract Amendment - State Department of Health Care Services - Substance Use Disorder
2 Services - FY2013-2014 - \$70,682,740]

3 **Resolution retroactively authorizing the Department of Public Health - Community**
4 **Behavioral Health Services (DPH-CBHS) to enter into an amended FY2013-2014**
5 **Contract for Substance Use Disorder Services with the State Department of Health Care**
6 **Services for the term of July 1, 2010, through June 30, 2014, in the amount of**
7 **\$70,682,740 and authorizing and designating the DPH County Alcohol and Drug**
8 **Administrator to sign said Agreement and to approve amendments for less than 10% of**
9 **the contracted amount.**

11 WHEREAS, On September 14, 2010, the San Francisco Board of Supervisors
12 approved a resolution (on file with the Clerk of the Board of Supervisors in File No. 101109)
13 retroactively authorizing DPH-CBHS to enter into a Combined Net Negotiated Amount and
14 Drug Medi-Cal Agreement with the State of California Department of Alcohol and Drug
15 Programs (DADP) for the term of July 1, 2010, through June 30, 2013, in the amount of
16 \$60,402,780; and

17 WHEREAS, On June 18, 2013, the San Francisco Board of Supervisors approved a
18 resolution (on file with the Clerk of the Board of Supervisors in File No. 130494) retroactively
19 authorizing DPH-CBHS to enter into a Combined Net Negotiated Amount and Drug Medi-Cal
20 Agreement – assigned to State Department of Health Care Services (DHCS) under the
21 FY2013-2014 Budget Act, which eliminated DADP – for the term of July 1, 2010, through June
22 30, 2014, in the amount of \$69,008,529; and

23 WHEREAS, On May 12, 2014, DHCS sent a contract amendment for substance use
24 disorder services that would (1) modify the contract Terms and Conditions and (2) increase

1 funding by \$1,674,211 for FY2013-2014 and (3) enable the contractor (the City) to provide
2 more of the same services as outlined in the original contract; and

3 WHEREAS, The DPH County Alcohol and Drug Administrator is designated to sign the
4 Combined Net Amount and Drug Medi-Cal Agreement and approve future amendments for
5 less than ten percent (10%) of the contracted amount; now, therefore, be it

6 RESOLVED, That DPH-CBHS is hereby authorized to enter into an amended FY2013-
7 2014 Substance Use Disorder Services Contract with DHCS for the term of July 1, 2010,
8 through June 30, 2014, in the amount of \$70,682,740 that would (1) modify the contract
9 Terms and Conditions and (2) increase funding by \$1,674,211 for FY2013-2014 and (3)
10 enable the contractor (the City) to provide more of the same services as outlined in the
11 original contract; and, be it

12 FURTHER RESOLVED, That the DPH County Alcohol and Drug Administrator is
13 hereby authorized and designated by the Board of Supervisors to sign said Agreement and to
14 approve Agreement amendments for less than ten percent (10%) of the contracted amount;
15 and, be it

16 FURTHER RESOLVED, That within thirty (30) days of the Agreement being fully
17 executed by all parties, the DPH County Alcohol and Drug Administrator shall provide the final
18 Agreement to the Clerk of the Board for inclusion into the official file.


