15 zoned and recommends approval; and,

16 WHEREAS, The Police Department has filed one (1) protest with the Department  
17 of Alcoholic Beverage Control under California Business and Professions Code, Section  
18 24013, and recommends that the Department of Alcoholic Beverage Control issue the  
19 liquor license; now, therefore, be it

20 **RESOLVED**, That in accordance with California Business and Professions Code,  
21 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
22 hereby determines that the issuance of a Type 42 on-sale beer and wine license to  
23 Vladimir Cood for BuzzWorks, Inc., dba SF:BuzzWorks:SOMA, located at 365-11<sup>th</sup>  
24 Street, will serve the public convenience or necessity of the City and County of San  
25 Francisco; and, be it

1           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
2 San Francisco hereby endorses and adopts the recommendations of the Police  
3 Department listed above, and recommends that the Department of Alcoholic Beverage  
4 Control issue the license with conditions.
