

1 [Accept and Expend Grant - Racial and Ethnic Approaches to Community Health - Heart
2 Healthy SF- \$799,159]

3 **Resolution retroactively authorizing the Department of Public Health to accept and**
4 **expend a grant in the amount of \$799,159 from Centers for Disease Control and**
5 **Prevention to participate in a program entitled “Racial and Ethnic Approaches to**
6 **Community Health - Heart Healthy SF” for the period of September 30, 2014, through**
7 **September 29, 2015.**

9 WHEREAS, Centers for Disease Control and Prevention has agreed to fund
10 Department of Public Health (DPH) in the amount of \$799,159 for the period of September 30,
11 2014, through September 29, 2015; and

12 WHEREAS, The full project period of the grant starts on September 30, 2014, and
13 ends on September 29, 2017, with years two and three subject to availability of funds and
14 satisfactory progress of the project; and

15 WHEREAS, As a condition of receiving the grant funds, Centers for Disease Control
16 and Prevention requires the City to enter into an agreement (Agreement), a copy of which is
17 on file with the Clerk of the Board of Supervisors in File No. 141100; which is hereby declared
18 to be a part of this Resolution as if set forth fully herein; and

19 WHEREAS, The purpose of this project will adapt and implement the national Million
20 Hearts Initiative in SF, focusing on Latinos and African Americans who have or are at risk for
21 cardiovascular disease. Healthy Hearts SF will expand upon the Million Hearts initiative to
22 incorporate the addition of alcohol and diabetes to the campaign's focus in order to meet the
23 health and cultural needs of San Francisco; and

24 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
25 partially reimburses DPH for three existing positions, one Epidemiologist II (Job Class No.

1 2803) at .20 FTE, one Health Program Coordinator III (Job Class No. 2593) at .20 FTE, and
2 one Senior Administrative Analyst (Job Class No. 1823) at .05 FTE for the period of
3 September 30, 2014 through, September 29, 2015; and


4 WHEREAS, The budget includes a provision for indirect costs in the amount of
5 \$10,392; now, therefore, be it

6 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant
7 in the amount of \$799,159 from Centers for Disease Control and Prevention; and


8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
9 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
10 be it


11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


