

1 [Accept and Expend Grant - Prevention and Family Recovery - \$99,900]

3 **Resolution retroactively authorizing the San Francisco Department of Public Health to**  
4 **accept and expend a grant in the amount of \$99,900 from the Superior Court of**  
5 **California, County of San Francisco, to participate in a program entitled “Prevention**  
6 **and Family Recovery” for the period of September 1, 2014, through August 31, 2015.**

8 WHEREAS, Superior Court of California, County of San Francisco, is the recipient of a  
9 grant award from Doris Duke Charitable Foundation/Children and Family Futures supporting  
10 the Prevention and Family Recovery grant; and

11 WHEREAS, With a portion of these funds, Superior Court of California, County of San  
12 Francisco has subcontracted with Department of Public Health (DPH) in the amount of  
13 \$99,900 for the period of September 1, 2014, through August 31, 2015; and

14 WHEREAS, As a condition of receiving the grant funds, Superior Court of California,  
15 County of San Francisco requires the City to enter into an agreement (Agreement), a copy of  
16 which is on file with the Clerk of the Board of Supervisors in File No.150129; which is hereby  
17 declared to be a part of this Resolution as if set forth fully herein; and

18 WHEREAS, The grant requires matching funds in the amount of \$132,841 from Human  
19 Services Agency Work Order; and

20 WHEREAS, The purpose of this project is to expand services for families participating  
21 in the San Francisco Dependency Drug Court, with a particular focus on children 0-8 years  
22 old; and

23 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant  
24 partially reimburses DPH for two existing positions, one Public Health Nurse (Job Class No.  
25

1 2830) at .25 FTE and one Marriage, Family & Child Counselor (Job Class No. 2931) at .43  
2 FTE for the period of September 1, 2014, through August 31, 2015; and

3 WHEREAS, A request for retroactive approval is being sought because DPH did not  
4 receive notification of the award until November 2014, for a project start date of September 1,  
5 2014; and

6 WHEREAS, Prevention and Family Recovery Grant does not contain indirect costs  
7 because Superior Court of California, County of San Francisco prohibits including indirect  
8 costs in the budget; and

9 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,  
10 therefore, be it

11 RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant  
12 in the amount of \$99,900 from Superior Court of California, County of San Francisco; and, be  
13 it

14 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of  
15 indirect costs in the grant budget; and, be it

16 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and  
17 expend the grant funds pursuant to San Francisco Administrative Code, Section 10.170-1;  
18 and, be it

19 FURTHER RESOLVED, That the Director of Health is authorized to enter into the  
20 Agreement on behalf of the City.




