1 [Contract Amendment - Fort Help, LLC - Substance Abuse Treatment Services - Not to  
2 Exceed \$14,563,665]

3 **Resolution approving the sixth amendment to the agreement between the Department**  
4 **of Public Health and Fort Help, LLC, for substance abuse treatment services for heroin**  
5 **and other opiate users with methadone and other opiate replacement therapies,**  
6 **increasing the contract amount by \$4,589,481 for a total contract amount not to exceed**  
7 **\$14,563,665 for the period of September 1, 2008, through June 30, 2018.**

9 WHEREAS, The Department of Public Health awarded a contract to Fort Help, LLC,  
10 under a Request for Proposals in 2008; and

11 WHEREAS, The Department established an agreement with Fort Help, LLC, for these  
12 services in 2008; and

13 WHEREAS, Fort Help provides substance abuse treatment services for heroin and  
14 other opiate users with methadone and other opiate replacement therapies under this  
15 contract; and

16 WHEREAS, The Department wishes to amend the contract, increasing the total  
17 contract amount by \$4,589,481 to \$14,563,665 in order to enable continued services through  
18 June 30, 2018; and


19 WHEREAS, Board of Supervisors' approval is required as the total contract amount is  
20 more than \$10,000,000; and

21 WHEREAS, A copy of this amendment is on file with the Clerk of the Board of  
22 Supervisors in File No. 150404, which is hereby declared to be a part of this resolution as if  
23 set forth fully herein; now, therefore, be it

1 RESOLVED, That the Board of Supervisors hereby authorizes the Director of Health  
2 and the Director of the Office of Contract Administration/Purchaser to execute an amendment  
3 to the contract with San Francisco Study Center to increase the contract by \$4,589,481 for an  
4 amount not to exceed \$14,563,665 for the period of September 1, 2008, through June 30,  
5 2018; and, be it

6 FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed  
7 by all parties, the Director of Health and/or the Director of the Office of Contract  
8 Administration/Purchaser shall provide the final contract to the Clerk of the Board for inclusion  
9 into the official file (File No. 150404).


