3 **Resolution determining that the transfer of a Type 21 on-sale general license from**  
4 **736 Divisadero Street to 900 North Point Street, E205 (District 2), to Adelaide and**  
5 **Mike Pollastro for Pacific Retail VFC1, Inc., dba Vom Fass Oils Vinegars and**  
6 **Spirits, will serve the public convenience or necessity of the City and County of**  
7 **San Francisco, in accordance with California Business and Professions Code,**  
8 **Section 23958.4, and recommending that the California Department of Alcoholic**  
9 **Beverage Control impose conditions on the issuance of the license.**

11 WHEREAS, Adelaide and Mike Pollastro are seeking the transfer of a Type 21  
12 off-sale general license from 736 Divisadero Street to 900 North Point Street, E205  
13 (District 2), for Pacific Retail VFC1, Inc., dba Vom Fass Oils Vinegars and Spirits; and,

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and,

16 WHEREAS, The Police Department has filed zero (0) protests with the  
17 Department of Alcoholic Beverage Control under California Business and Professions  
18 Code, Section 24013, and recommends that the Department of Alcoholic Beverage  
19 Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Sales of alcoholic beverages shall be permitted between the hours 10:00  
22 a.m. to 10:00 p.m. daily; 2) No noise shall be audible beyond the area under control of  
23 the license; 3) No wine shall be sold with an alcoholic content of great than 15% by  
24 volume except for "Dinner Wines" that have been aged two years or more and  
25 maintained in corked bottles; 4) Wine shall not be sold in bottles or containers smaller

1 than 500 ml; and 5) The sale, service and consumption of powder alcohol or like non-  
2 liquid alcoholic beverage based product is prohibited; now, therefore, be it

3           RESOLVED, That in accordance with California Business and Professions Code,  
4 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
5 hereby determines that the transfer of a Type 21 off-sale general license from 736  
6 Divisadero Street to 900 North Point Street, E205 (District 2), to Adelaide and Mike  
7 Pollastro for Pacific Retail VFC1, Inc., dba Vom Fass Oils Vinegars and Spirits, will  
8 serve the public convenience or necessity of the City and County of San Francisco; and,  
9 be it

10           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
11 San Francisco hereby endorses and adopts the recommendations of the Police  
12 Department listed above and recommends that the Department of Alcoholic Beverage  
13 Control issue the license with those conditions.
