3 **Resolution retroactively authorizing the Department of Children, Youth and Their**  
4 **Families (DCYF) to accept and expend grant funding in the amount of \$600,000 from**  
5 **the Cities for Financial Empowerment Fund for the Summer Jobs Connect Program to**  
6 **support 155 youth employment opportunities and increased banking access, and**  
7 **financial education for all youth in DCYF-funded summer workforce programs for the**  
8 **period April 1, 2015, through March 31, 2016.**

10 WHEREAS, The City and County of San Francisco was awarded a grant on April 20,  
11 2015, in the amount of \$600,000, from the Cities for Financial Empowerment Fund (CFE) to  
12 fund a summer employment program for youth and young adults, as well as develop and  
13 implement tools and strategies to enhance youth and young adult financial literacy; and

14 WHEREAS, The funding will provide 155 paid employment opportunities for youth ages  
15 14-24 in support of San Francisco's Summer Jobs+ Initiative; and

16 WHEREAS, Summer employment assist youth in developing skills needed to gain  
17 independent employment; gaining a better understanding of the relevance of their education  
18 and contributing to the financial health of their families; and

19 WHEREAS, The Department of Children, Youth and Their Families will submit all fiscal  
20 and programmatic reports to the Cities for Financial Empowerment Fund; and

21 WHEREAS, The Department proposes to maximize use of available grant funds on  
22 program expenditures by not including indirect costs in the grant budget; and


23 WHEREAS, The grant does not require an ASO amendment; now, therefore, be it

24 **RESOLVED**, That the Department of Children, Youth and Their Families is hereby  
25 authorized to retroactively accept and expend the grant from the Cities for Financial


1 Empowerment Fund in the amount of \$600,000 from April 1, 2015, through March 31, 2016;  
2 and, be it


3 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of


