# 121194 [Administrative Code - Water Enterprise Capital Cost Recovery Payment Surcharge Fund]

Ordinance amending the San Francisco Administrative Code, Chapter 10, Article XIII, to create the Public Utilities Water Enterprise Capital Cost Recovery Payment Surcharge Fund. ASSIGNED UNDER 30 DAY RULE to Budget and Finance Committee.
