Upon adoption of such a motion, the Committee Clerk shall administer an oath to the person testifying before the Government Audit and Oversight Committee. Any testimony following such an oath shall be given under penalty of perjury.'; and adding 'Rule 4.27 Administration of Oaths. By oral motion adopted by a majority of the members of the Board, the Board may instruct the Clerk to administer an oath to any person testifying before the Board, excluding members of the general public offering comment during that portion of the meeting.
