### **190088 [Liquor License Transfer - 4800 California Street - On the Run Market]**

Hearing to consider that the transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor license to Mazen Gaber Gad, doing business as On the Run Market, located at 4800 California Street (District 1), will serve the public convenience or necessity of the City and County of San Francisco. (Public Safety and Neighborhood Services Committee)

01/25/19; RESPONSE RECEIVED. The Planning Department submitted their recommendation for approval; the establishment at 4800 California Street (d.b.a. On the Run Market) is an existing, legal-nonconforming General Grocery use. The continuation of said use is permitted under Planning Code, Section 178(b). The ABC Type-21 license transfer is recommended for approval under the following conditions: the retail use shall function as a "General Grocery" use (as defined in Planning Code, Section 102), and as such, the display and sale of alcohol is limited to 15% or less of the total Occupied Floor Area of the establishment; and hours of operation shall not extend past 10:00 p.m., per Planning Code, Sections 186, 710, and 716.

Hearing to consider that the issuance of a Type-42 on-sale beer and wine public premises liquor license to 1and8 Inc., doing business as the Museum of Ice Cream, located on the mezzanine level of 1 Grant Avenue (District 3), will serve the public convenience or necessity of the City and County of San Francisco. (Public Safety and Neighborhood Services Committee)

02/20/19; REFERRED TO DEPARTMENT. Referred to the Planning and Police Departments for comment and recommendation.

02/21/19; RESPONSE RECEIVED. The Planning Department submitted their recommendation for approval; recommend approval of Type-42 ABC license in conjunction with Bar use, principally permitted in the C-3-R Zoning District per Planning Code, Section 210.2. Applicant informed that DPH Restaurant referral must be obtained.

03/13/19; RESPONSE RECEIVED. The Police Department submitted a response recommending approval with the following conditions:

- 1) sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 11:00 a.m. and 12:00 a.m. Sunday through Wednesday, and 11:00 a.m. and 1:00 a.m. on Thursday, Friday, and Saturday;
- 2) petitioner(s) shall actively monitor the area under their control in an effort to prevent the loitering of persons on any property adjacent to the licensed premises as depicted on the most-recently-certified ABC-253;
- 3) the sale of alcoholic beverages for consumption off the premises is prohibited.

**190164 [Police Code - Acceptance of Cash by Brick-and-Mortar Businesses]****Sponsors: Brown; Fewer, Walton, Peskin, Safai, Mandelman, Ronen and Yee**

Ordinance amending the Police Code to require, in general, that brick-and-mortar businesses accept payment in cash in connection with the purchase of goods and services other than professional services.

02/20/19; REFERRED TO DEPARTMENT. Referred to the Police Department, Sheriff's Office, the Public Defender, the District Attorney, and the Human Rights Commission for informational purposes. Referred to the Small Business Commission and the Youth Commission for comment.

03/04/19; RESPONSE RECEIVED. On March 4, 2019, the Youth Commission voted unanimously to support the ordinance.

03/19/19; SUBSTITUTED AND ASSIGNED to Public Safety and Neighborhood Services Committee. Supervisor Brown introduced a substitute Ordinance bearing a new title.

03/27/19; REFERRED TO DEPARTMENT. Substitute legislation referred to the Police Department, Sheriff's Office, the Public Defender, the District Attorney, and the Human Rights Commission for informational purposes. Referred to the Small Business Commission and the Youth Commission for comment.

04/10/19; RESPONSE RECEIVED. Response received from the Small Business Commission recommending conditional approval upon adoption of two proposed amendments:

- 1) Responsive to transactions that may total in the thousands of dollars, include an exception that would establish a reasonable cap on the total amount of the cash transaction that the business must accept; and
- 2) Responsive to possible unintended and situational negative consequences that may occur due to requiring the acceptance of cash, under enforcement, include specific direction for the San Francisco County Sealer to develop administrative guidelines in which a business may be situationally exempt from the case acceptance requirement.

**Chair Mandelman moved that this Ordinance be AMENDED, AN AMENDMENT OF THE WHOLE BEARING SAME TITLE, by adding a provision that a Brick-and-Mortar Business may not charge a fee or place any other condition on its acceptance of Cash; on Page 5, Lines 1-9, by inserting '(c) Single Transactions Above \$5,000. Where a single transaction involves the purchase of one or more goods and/or services, the total price of which (including tax) exceeds \$5,000, a Brick-and-Mortar Business must accept Cash that is proffered as payment for any amount up to \$5,000, but may refuse to accept Cash as payment for the remainder of the amount due. By way of example but not limitation, if a customer purchases an item or items of jewelry the total price of which (including tax) is \$7,500, the customer would be entitled to pay up to \$5,000 in cash, but the Brick-and-Mortar Business would be permitted to require the customer paying \$5,000 in cash to pay the remaining \$2,500 due using some form of payment other than Cash.'; on Page 6, Lines 12-17, by inserting 'SEC. 5506. TREASURER'S REPORT. By no later than December 31, 2026, the Treasurer shall submit a report to the Board of Supervisors and the Mayor on the findings contained in the report on the 2025 National Survey of Unbanked and Underbanked Households issued by the Federal Deposit Insurance Corporation. The report submitted by the Treasurer may, but need not, include recommendations concerning this Article 55.'; and by specifying that the ordinance shall become operative 90 days after enactment.
