## SPECIAL ORDER 2:00 P.M. - Mayor's Appearance Before The Board

There were no questions submitted from the eligible Supervisors representing Districts 1, 2, 3, or 4. Mayor London N. Breed acknowledged the women on the Board and wished them Happy Women's History Month. Mayor Breed then provided an update on the vaccine dissemination in San Francisco, with more than 196,000 already receiving their first dose and more than 90,000 having received their second dose. Educators have been given priority in an effort to return students to in-person learning with April 12, 2021, being the first target date. Efforts continue as San Francisco moves toward entering the Orange Tier. Following public comment this matter was filed. No further action was taken.
